



24 Hour Tan is not staffed at all times and members agree to follow all rules and use common sense while inside the facility. There are MONITORED security cameras 24-hours a day, 7 days a week in all permissible areas of the facility. All activity in these areas is recorded and reviewed on a regular basis. Any violation of the rules and regulations of this facility will be sufficient cause for termination of membership and immediate deactivation of their membership key fob.

1. This facility is under 24-hour recorded video surveillance and MEMBER ACCESS and key fob usage is logged.
2. MEMBER agrees to abide by all membership regulations of 24 Hour Tan. MEMBER agrees to comply with stated and customary rules for participation and use of equipment. Members agree to carefully follow all verbal instructions from staff as well as all written instructions posted to ensure proper operation of the automated equipment in our facility. Members will be liable for any damage to the equipment arising from, but not limited to acts of negligence, abuse and/or improper usage.
3. Minors: Under 18 years old may not use the facility during unstaffed hours. Up to 18 years must be accompanied by parent or legal guardian and can only use the facility during staffed hours. Children under the age of 14 are not allowed to enter the facility unsupervised and they are not allowed to wait in the waiting area or individual rooms.
4. Members may not bring in guests during non-staffed hours at any time, under any circumstances. If this policy is violated MEMBER may have their membership suspended or canceled. In addition, MEMBERS may not allow anyone else to use their Key Fob or package and must alert 24 Hour Tan immediately if it is lost or stolen. If this policy is violated, MEMBER may be assessed a penalty of up to \$250.00
5. NONMEMBERS MUST ENROLL DURING STAFFED HOURS AND WILL NOT BE ALLOWED INTO THE FACILITY DURING NON-STAFFED HOURS, NOR SHOULD THEY EXPECT ANYONE ELSE TO LET THEM INTO THE FACILITY. New and replacement Key Fobs can only be issued by our STAFF during staffed hours.
6. Only one person per room at any time.
7. MEMBERS are responsible for safekeeping their personal belongings. 24 Hour Tan and its employees are not responsible for any damage or theft of personal property.
8. To ensure a clean and sanitary environment, MEMBER agrees to wipe down the tanning bed **before** and **after** each use with provided sanitizer.
9. At the end of each session, MEMBER agrees to promptly exit the room and must not remain longer than necessary to dress and sanitize the equipment.
10. MEMBER acknowledges and agrees to not engage in horseplay, loud or vulgar language, or abuse of the equipment upon 24 Hour Tan premises nor shall MEMBER molest, badger, assault or harass other 24 Hour Tan MEMBERS, guests, or employees. If MEMBER engages in such behavior, their Membership will be cancelled and Key Fob immediately deactivated.
11. Smoking, smokeless tobacco, alcohol or the use of non-prescription drugs are strictly prohibited on 24 Hour Tan premises.



12. It is prohibited for anyone, other than an authorized law enforcement officer to bring or have in possession a weapon, explosive or other items classified by law as a weapon at the facility.
13. 24 Hour Tan retains the right to modify these policies without warning. Reasonable rules and regulations may be posted in 24 Hour Tan from time to time and all MEMBERS shall be subject to strict compliance therewith.
14. Arbitration: All disputes (except small claims under \$1000) will be settled by binding arbitration before a single arbitrator under the authority of the Federal Arbitration Act, conducted by and in accordance with the rules and procedures of the American Arbitration Association. The arbitration will take place in the county in which 24 Hour Tan is located unless otherwise agreed. The decision of the arbitrator will be final and binding on all parties and may be enforced by a judgment entered upon the arbitration award by any state or federal court in this state.
15. Should this Agreement be placed in the hands of an attorney for the violation of any provision contained herein, the parties agree 24 Hour Tan shall be entitled to recover all costs and expenses resulting there from, including a reasonable amount as attorneys fees.
16. The parties hereby agree that the whole agreement between the parties relating to the subject matter hereof is contained in this Agreement and shall supersede any prior understandings, arrangements, commitments, or undertakings of the parties, whether written or oral, express, or implied.
17. This Agreement may not be amended or modified except by an instrument in writing executed by the parties hereto.
18. This Agreement shall be governed by the laws of the State of Minnesota, without giving effect to principles of conflicts of law.
